I declare the following statements to be true:

Sub-criterion 7.1: Restrictions on ingoing substances classified under Regulation (EC) No 1272/2008

- I declare that the adhesive does not contain ingoing substances (added as such or in mixtures) that are assigned any of the hazard classes, categories and associated hazard statement codes stated in Table 6 in Annex I to the Commission Decision
- I declare that the adhesive does not contain ingoing substances (added as such or in mixtures) in concentrations greater than 0,010% (weight by weight) that are assigned any of the hazard classes, categories and associated hazard statement codes stated in Table 7 in Annex I to the Commission Decision
- I declare that the chemical product contains dipropylene glycol dibenzoate
Dipropylene glycol dibenzoate can only be used in hot melt adhesives that are used to indicate wetness
- Dipropylene glycol dibenzoate is used in hot melt adhesives that are used to indicate wetness
- I declare that the adhesive contains titanium dioxide (nano form)
Titanium dioxide (nano form) can only be used as pigment. The adhesive cannot be used in powder or spray form

Exception:

- Substances considered to be potential endocrine disruptors in category 1 or 2 on the EU's priority list of substances that are to be investigated further for endocrine disruptive effects¹.

Sub-criterion 7.3.2: Fragrances

Sub-criterion 7.3.4: Inks and dyes
