



SPEAKERS



Maroš Šefčovič

Maroš Šefčovič (born in 1966) is a Slovak politician and a career diplomat, who since 22 August 2023 serves as Executive Vice President for the European Green Deal, Interinstitutional Relations and Foresight. Before that, since 1 December 2019 he served as Vice-President of the European Commission in charge of Interinstitutional Relations and Foresight. In this capacity, he leads the Commission's work on the European Green Deal, interinstitutional relations, better policymaking, strategic foresight and the European Battery Alliance. He is also responsible for the European Union's relations with Western non-EU countries, notably Andorra, Iceland, Monaco, Norway, Lichtenstein, San Marino and Switzerland. He also cochairs the EU-UK Partnership Council under the Trade and Cooperation Agreement and the EU-UK Joint Committee for the implementation of the Withdrawal Agreement.

European Affairs have been at the centre of Mr Šefčovič's career for almost two decades. In 2014, he was elected as a Member of the European Parliament. From 2010-2019, he was Vice-President of the European Commission in charge of initially Interinstitutional Relations and Administration, and then the Energy Union. In 2009-2010, he was European Commissioner for Education, Training, Culture and Youth. From 2004-2009, he was the Permanent Representative of the Slovak Republic to the European Union, steering the country's integration in the European Union, such as its entry to the Eurozone and the Schengen area. As a diplomat by profession, he served between 1992 and 2004 in Zimbabwe and Canada and as Ambassador of Slovakia to Israel.

He graduated from the University of Economy in Bratislava, Slovakia, and the Moscow State Institute for Foreign Relations. He holds a degree as Doctor of Law and a PhD of European Law from Faculty of Law at the Comenius University in Bratislava, Slovakia. He also undertook training in diplomacy at Stanford University, USA.

A book «Driving the EU forward – talks with Maroš Šefčovič» focuses on his first mandate as the Commission Vice-President. In 2018, he was awarded the title of Doctor Honoris Causa at the Pan-European University in Bratislava, Slovakia.

Mr Šefčovič is married and father of 3 children, Helena, Martina and Maroš. Two dogs and a cat are also part of the family.



Vivianne Heijnen

Vivianne Heijnen (Christian Democratic Alliance (CDA)) was appointed Minister for the Environment on 10 January 2022. Between 2009 and 2018 she was head of the Maastricht University Campus in Brussels. In 2018 she became a member of the Maastricht municipal executive with responsibility for the economy, housing, regional policy, and social innovation. Ms Heijnen was born on 8 October 1982 in Spaubeek. When asked about what motivates her as a minister, her response is as follows: 'I want the Netherlands to be a country that is liveable and accessible for everyone and where we reuse more. I'm committed to reducing travel time in a sustainable way, with a particular focus on border regions, cities and our neighbouring countries.



Leena YLÄ-MONONEN

Leena Ylä-Mononen is the Executive Director of the European Environment Agency since 1 June 2023. She was born in Pohjaslahti, Finland in 1963. Ms Ylä-Mononen has a master's degree in environmental sciences from Helsinki University, specialising in ecotoxicology and chemicals risk assessment and management.

Before joining the European Environment Agency, she was Director General at the Ministry of Environment of Finland. She managed the Climate and Environmental Protection Department, dealing with environmental policy issues and EU files related to climate change, air pollution, industrial pollution, circular economy, sustainable consumption and production, waste management and the prevention of environmental risks from chemicals.

Before joining the Ministry in 2019, Ms Ylä-Mononen worked for over 11 years in management positions in the European Chemicals Agency (ECHA) in Helsinki. Before joining ECHA in 2007, she worked in the European Commission, Directorate-General for Environment, on policy files related to chemicals and pesticides.

Earlier in her career she worked in the Finnish Environment Institute (SYKE) on environmental risk assessment and management of industrial chemicals, biocides and pesticides.

Throughout her career, Ms Ylä-Mononen has been involved in international cooperation at the Nordic, European, OECD and global levels, and in the negotiations and implementation of multilateral environmental agreements on chemicals, waste and climate change.

Ms Ylä-Mononen speaks fluent English, in addition to her native Finnish, and has working level skills in French and Swedish. She enjoys nature, visual arts, literature and history.



Chantal ZEEGERS

Chantal Zeegers has been working as vice mayor in the Municipality of Rotterdam since 16 June 2022. She is responsible for the Climate, Building and Housing portfolios.

Previously, Ms Zeegers has held a variety of different positions within the Ministry of Education and the Municipality of Rotterdam. She has been active in politics for the D66 party since 2011. She started out as an Executive Director of the Hillegersberg-Schiebroek submunicipality, specifically focussed on outdoor spaces, sustainability and traffic and transport. She was the D66 Party Chairperson in Rotterdam's municipal council between 2018 and 2022.

Other positions include vice presidency of the regional environmental protection agency DCMR, and member of the regional steering committee JTF Rijnmond and member of the national monitoring committee of the Just Transition Fund.



Bent MADSEN

Since 2010 Bent Madsen has filled the chair as CEO of BL – Danish Social Housing, the national federation of social housing organizations in Denmark.

Bent holds the Presidency of Housing Europe (the European Federation of Public, Cooperative and Social housing), and is Chairman of NBO - Housing Nordic (the Nordic association of co-operative social housing).

He serves as member of the boards of the Danish Chamber of Commerce, the Economic Council of the Labour Movement, The Social Network, the Danish Disability Council, and the association «Hjem-til-Alle» (A Home for Everybody). Among his prior positions is membership of the Danish Competition Council.Bent holds a Master of Economics from the University of Copenhagen.

Mark LAWRENCE



Prof. Dr. Mark Lawrence is scientific director at the RIFS (formerly IASS) in Potsdam and an integrative scientist who addresses key challenges of the Anthropocene by bringing together and applying a wide range of academic expertise in his team, including his own background in atmospheric science, as well as going beyond this interdisciplinary foundation to also involve societal actors in a transdisciplinary approach.

His main research topics include air pollution, climate change, climate geoengineering, environment-related governance of vulnerable regions like the Himalayas and the Arctic, and the interface between sustainability and spirituality.

Prof. Lawrence received his Ph.D. in 1996 from the Georgia Institute of Technology. From 2000 until 2011 he was a research group leader at the Max Planck Institute for Chemistry in Mainz. He served as interim professor for meteorology at the University of Mainz during 2009-2010 and moved to the IASS in 2011. In 2014, he was appointed to be an Honorary Professor at the University of Potsdam.

Prof. Lawrence is the author or co-author of over 180 peer-reviewed publications, with an h-index of 75 on Google Scholar. He has led various international projects and has been serving on the editorial and advisory boards of various journals and on various international committees, including having been co-chair of the International Global Atmospheric Chemistry program (IGAC) from 2015-2018, and currently being co-chair of the German Science Platform Sustainability 2030, a member of the German Council for Sustainable Development, and in the Board of Directors of the German Climate Consortium.

Petros KOKKALIS



Petros Kokkalis has been actively involved in public service for the past 25 years, developing social innovation focused on human and sustainable development.

He studied Modern History at the University of Hampshire, and earned his master's degree in public administration at Harvard Kennedy School of Government.

He is co-founder of the non-governmental environmental organization Earth whose work on environmental awareness and education for sustainable development has been awarded by the International Union for the Protection of the Environment (IUCN).

He was elected and served as the Vice-Mayor responsible for economic development and climate change in the municipality of Piraeus (2014 - 2019), where he promoted sustainable entrepreneurship and support of start-ups in the maritime economy.

The European Commission has acknowledged his work, awarding the Blue Growth Piraeus initiative at the European Entrepreneurship Promotion Competition 2018.

During his term of office he led the humanitarian support during the Refugee Crisis in the period 2015-2016 and served as the President of the Municipal Council for Refugees.

In 2019 he was elected MEP, representing Kosmos, a political movement seeking to deliver the UN SDG's, with the Progressive Alliance - Syriza ticket.





Maja Markovčić Kostelac took up the position of Executive Director of the European Maritime Safety Agency (EMSA) on 1 January 2019. She is responsible for the running and development of the Agency under the oversight of its Administrative Board.

Starting out as a maritime lawyer, she has subsequently gained long-standing experience in the maritime field in both the public and private sector.

Prior to joining EMSA, Ms Markovčić Kostelac was State Secretary for Croatia's Ministry of the Sea, Transport and Infrastructure. Her duties entailed developing strategies, policies and legislation in the area of maritime transport, maritime safety, security and environmental protection. In this role, she also led the Croatian delegation in a range of international forums at the United Nations, such as the International Maritime Organization (IMO) and the International Labour Organization (ILO).

During her time at Croatia's Ministry of the Sea, Transport and Infrastructure she held a number of positions, including Director of the Maritime Policy Directorate. She also served as Director of the Croatian Shipowners' Association (Mare Nostrum).

Since joining EMSA, Ms Markovčić Kostelac has established the Agency's five-year strategy (2020-2024) and organises its implementation. She has led EMSA's work on a range of strategic and operational issues, including the maritime dimension of the European Green Deal, the development of enhanced digital solutions for national level administrations and relevant authorities, and the provision of support at international level to the European Commission and Member States at the IMO.



Anita MÄKINEN

Dr Anita Mäkinen is the Alternate Permanent Representative of Finland to the IMO. She works also as Chief advisor to the Finnish Transport and Communications Agency. She covers all shipping related environmental issues and the international and regional organizations wherein these are discussed, in addition to the IMO, EU, HELCOM and the Arctic Council

Dr Mäkinen has been serving as the Vice-Chair of the IMO PPR subcommittee since 2020 and serves as the Vice-Chair of the European Sustainable Shipping Forum (ESSF) sub-group on Sustainable Alternative Power for Shipping. In HELCOM she co-chairs the HELCOM Green Team meetings.

In her position she has been also member of the Finnish delegation to the United Nations Framework Convention on Climate Change (UNFCCC) e.g. in Paris in 2015 and the Ocean Conference in New York and Lisbon in 2017 and 2022, respectively.

Before her present position, Dr Mäkinen worked as the Head of Marine Environment Protection Unit of the Finnish Transport Safety Agency and in different positions at the University of Turku. At the University she supervised Finnish and foreign students' Master and PhD studies.

Dr Anita Mäkinen graduated from the University of Turku. She wrote her doctoral thesis on marine biology at the Åbo Akademi University and holds an Adjunct Professor degree (Docent) at the University of Helsinki in the same discipline.

She has published several peer-reviewed scientific articles and articles in journals and newspapers.



Philippos PHILIS

Philippos Philis is the founder of Lemissoler and has been Managing Director since its establishment in 1996.

He has been appointed as Chairman and CEO of Lemissoler Group since 2009. The Group is active in ship-owning, ship management, ship commercial operations, and chartering, as well as in R&D with a focus on enhancing the ship's efficiency and decreasing the carbon footprint.

Philippos is elected President of the Board of Directors of the European Community Shipowners' Associations (ECSA), past President of the Board of Directors of the Cyprus Shipping Chamber (CSC) and has been Chairing the Board of Directors of the Cyprus Shipowners' Employers Association (CySEA) from 2016-2021. He is an elected member of the American Bureau of Shipping (ABS), a member of the DNV GL Cyprus Committee, and a member of the Advisory Committee of the West of England P&I Club. He served as a member of the Board of Directors of the International Chamber of Shipping (ICS) and the Board of Directors of USB Bank.

Philippos graduated from RWTH Aachen in Mechanical Engineering, and he is also a Harvard Business School (HBS) graduate. He was awarded an Honorary Doctorate by the School of Management and Economics of the Cyprus University of Technology (CUT).




Eric VAN DER SCHANS

Eric van der Schans is Director Environmental Management at the Port of Rotterdam Authority since 1 September 2015

Born in Enschede, the Netherlands in 1971, Eric holds a master degree in chemical engineering from the University of Twente.

He started his career at Stork in in 1996 as environmental & safety consultant for the Oil & Gas industry and worked on various projects in Europe and the Middle East. In 2000 he joined Royal Haskoning DHV and continued to work as consultant, project manager and team leader. In 2005 he joined Antea Group to lead their safety consultancy practice. In later years he has been responsible for international acquisition strategy of Antea Group as well as international business development. As director Environmental Management he is responsible for spatial planning, environment and CSR within the Port of Rotterdam Authority.

In addition to his role with the Port of Rotterdam Authority, Eric van der Schans is Chairman of Environmental Shipping Index (ESI) Working Group



Carlos MORENO

Internationally renowned researcher, Carlos Moreno is Scientific director of the Chair "Entrepreneurship – Territory – Innovation", IAE Paris - Sorbonne University (France).

Carlos Moreno earned recognition as a scientist with an innovative mind, pioneer works and his unique approach on urban issues.

He is also a scientific advisor of national and international figures of the highest level.

He works at the heart of issues of international significance as a result of his research, bringing an innovative perspective on urban issues and offering solutions to the issues faced by the cities, metropolises and territories during the 21st century.

Some of his concepts traveled the world: the 'Human Smart City', the '15-Minute City', the '30-Minute Territory'.

In 2022, he is leading the launch of the Global Observatory of proximities at the World Urban Forum #WUF11 with UN-Habitat, C40 Cities, UCLG and other partners.



Winfried HERMANN

Winfried Hermann is the minister of the Ministry of Transport Baden-Württemberg in the cabinet of Prime Minister Winfried Kretschmann since Mai 2011.

Minister Hermann is in charge of topics concerning road engineering, public transport, bicycle traffic, foot traffic, rail traffic, car traffic, air traffic, barge traffic and infrastructure. This also includes air pollution control and the protection of nature and against noise.

A sustainable new mobility is the guiding principle of the policy of the Ministry of Transport. Human beings, their health and mobility needs and the environment are always the central focus of all the activities.

Minister Hermann is also a member of The Green Party and of the State Parliament of Baden-Württemberg.

Born on 19. July 1952 and raised in Rottenburg am Neckar. Lives in Stuttgart, is married and has one child.



Annika DEGEN

Annika Degen is Deputy Director at UITP's Europe Department and responsible for mobility strategy, data policy, digitalization and ticketing.

Meredith Glaser serves as the Executive Director of the Amsterdam-based research and education non-profit, the Urban Cycling Institute, and tenured lecturer of urban planning at the University of Amsterdam.

Meredith's academic and professional career is underpinned by her passion for fostering community, dialogue, and collaboration through learning and co-creation for advancing sustainability.

With nearly 20 years of teaching experience and a multi-disciplinary background in public health, urban planning and environmental design, Dr. Glaser brings a holistic understanding and honest broker approach to social inquiry and change.

Her academic research on and experience with cycling policy and city-to-city learning has advanced Dr. Glaser as a leading subject-matter expert and one of the most sought-after educators for professional development about Dutch cycling systems.

She directs the summer program Planning the Cycling City and co-developed the Coursera on-line course Unraveling the Cycling City, with over 20k enrollments.

She also serves on several boards, including CROW, a Dutch knowledge platform for bicycle policy, Bloomberg's Bici Program, and the Cycling Research Board. She received her PhD in urban planning from the University of Amsterdam, supervised by her colleague and long-term collaborator, Prof. Dr. Marco te Brömmelstroet.

Stefan OLSSON



Stefan Olsson is a Swedish lawyer with degrees in international and tax law. Having joined the European Commission in 1996, he dealt with fundamental rights issues as well as social dialogue.

He was assistant to the Director General for Employment and Social Affairs (2000-2005) before leading units dealing with social and employment law and policy as well as administrative affairs.

As from 1 November 2015, he took up the position of Director in DG Employment, Social Affairs and Inclusion. He was responsible for the management of the European Social Fund in Romania, Bulgaria, Malta and Spain, for the implementation of the Employment Strategy through tools such as the Youth Guarantee, the Long-term Unemployment Recommendation and the network of Public Employment Services, as well as legislative and policy issues relating to working conditions including health and safety at work.

From 1 September 2022, he serves as Deputy Director-General responsible for policy issues in DG Employment, Social Affairs and Inclusion.



Kęstutis KUPŠYS

Kęstutis Kupšys is the Vice-President of the Lithuanian Consumers Alliance, which (as of October 2023) unites 10 consumer associations. The Alliance has been a member of the European Consumer Organisation (BEUC) since 2013.

After a two-decade-long career in finance, political consulting and public relations, Kestutis Kupšys joined the consumer rights movement in 2011 when he was chosen to supervise the establishment of 'For Honesty in Banking', a consumer advocacy organisation destined to steer diverse civic and legal campaigns of vulnerable consumers hit by the financial crisis of 2008–2009. Kęstutis Kupšys currently serves as the Executive Director of this organisation, which, along with the Lithuanian Consumers Alliance, has been actively participating in national and European debates on various essential issues, including overindebtedness, the affordability and accessibility of financial services, financial literacy, sustainable ('green') finance, and socially responsible savings and investment. In 2014-2015, as Lithuania was preparing to enter the Eurozone, he led a national campaign monitoring consumer rights during the litas-to-euro transition period.

In April 2018, Kęstutis Kupšys was assigned the role of an alternate member of the European Economic and Social Committee in the Civil Society Organisations' Group. He was appointed as a full

He also currently represents consumer interests in the Financial Services User Group at DG FISMA as well as in the Occupational Pensions Stakeholder Group at EIOPA. He is also a Liaison Officer for ANEC - organisation representing the European consumer voice in standardisation - in the ISO international standardisation committee 'ISO/TC 322' on Sustainable Finance. In addition, he takes part in the work of various BEUC working groups (on Financial Services, Sustainability, Trade, and Energy).

Kęstutis Kupšys graduated from Vilnius University with a degree in Economic Cybernetics/Systemic Analysis of the Economy (in 1995), while his supplementary study interests encompassed Financial Markets and Business Administration (via Catholic University Eichstätt, Germany, 'Gaststudium' program in 1992–1993) and Philosophy (Vilnius University, 1995–1997).

Virginijus Sinkevičius is the present Commissioner for the Environment, Oceans and Fisheries, at the European Commission. Mr Sinkevičius was from 2017 to 2019 Minister of Economy, and before he was leading the Committee of Economy at the Parliament of Lithuania.

Mr Sinkevičius was elected to the Parliament in October 2016. Prior, he was a Team Lead for Regulatory Affairs at Invest Lithuania.

Mr Sinkevičius holds BA in International Relations and Affairs from Aberystwyth University and Master 's degree in European International Affairs from Maastricht University.

Ahmed ABOUTALEB



Ahmed Aboutaleb (born 1961 in Beni Sidel, Morocco) has been Mayor of Rotterdam since 2009.

Previously, he represented the PvdA (Labor Party) as State Secretary for the Ministry of Social Affairs and Employment in the fourth Balkenende cabinet (2007-2008) and as an alderman in Amsterdam (2004-2007).

In the mid-1980s, Aboutaleb started his career in journalism. He was a discussion leader for RVU Television, made programs for Radio Stad Amsterdam and Radio Noord-Holland, and reported for Veronica Radio, NOS Radio and RTL News. In 1991, he moved to public services, holding positions with the Ministry of Welfare, Health and Culture, the Social and Economic Council of the Netherlands (SER) and Statistics Netherlands (CBS). In 1998 he became an administrator for the Forum institute for multicultural development, and in 2002 he became director of the City of Amsterdam's sector of Social, Economic and Cultural Development (MEC).

Mayor Aboutaleb strongly advocates the values enshrined in the Dutch Constitution: freedom of religion, freedom of speech and the principle of non-discrimination. In his view, obtaining Dutch citizenship entails a responsibility to respect and uphold those values and to take part in building the We Society. The more people take part in which, the stronger and more resilient that society will be, both in good and bad times. He'll regularly take neighbourhood strolls throughout Rotterdam to have talks with residents about what concerns them.

In 2015, Aboutaleb published two books: an HJ Schoo Reading (published by Elsevier magazine) titled De roep van de stad ('The City's Call'), covering the leading role cities and urban regions can play at the national and international level, and Droom & Daad ('Dream & Deed'), which was published for the History Week of the Collective Promotion of the Dutch Book foundation (CPNB). In Droom & Daad, he tells a Rotterdam war story to present how to ensure a stable, peaceful society.

Patrick CHILD



Patrick CHILD is currently Deputy Director-General in DG Environment at the European Commission with particular responsibility for the EU's zero pollution strategy, chemicals legislation, urban agenda, research and innovation for environment and communication.

He is also the Mission manager for the Climate-Neutral and Smart Cities Mission, which aims to reach 100 climate-neutral cities by 2030. From 2016-2021, he was Deputy Director-General in DG Research and Innovation (R&I) at the European Commission.

As member of the Board of DG R&I, he followed in particular research and innovation in clean energy and climate technologies as well as the R&I dimension of the post-COVID recovery and resilience strategy and Horizon Europe mission on Cancer. His international roles included Commission representative and chair of the steering committee of Mission Innovation (a coalition of 24 countries and the EC working to accelerate global clean energy innovation) and lead co-chair of the Group of Earth Observations (GEO).

Until April 2016, Patrick Child was Managing Director of the European External Service with responsibility for administration and finance, covering human resources policy, security and the budget. Before he took up this post in 2011, he was director in the EC External Relations Directorate-General in the responsible for managing the network of Commission delegations.

He has previously served as head of cabinet for External Relations Commissioners Benita Ferrero-Waldner and Chris Patten. With a background in the UK Finance Ministry, he joined the European Commission in 1994, where he started in the Economic and Monetary affairs Directorate General before becoming Commission press spokesman for economic and monetary union from 1995-1999.

Mr Child studied mathematics at Cambridge University. He is married with two children.

Javi LÓPEZ



Javi López is an MEP from PSC-PSOE and a member of the Progressive Alliance of Socialists and Democrats (S&D) in the European Parliament since 2014.
